BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE CONFEDERATED SALISH AND KOOTENAI TRIBES THAT

WHEREAS, The Tribal Council established policy by Resolution 96-83 to make per-capita payments to tribal members three times annually during the months of December, April and August for each fiscal year; and

WHEREAS, said policy states that three equal per capita payments of \$400.00 will be made annually and that one-half (1/2) of each per capita distribution for each minor child enrolled in the Tribes is to be issued to said minor's parent or legal guardian and the other one-half (1/2) is to be placed in a trust account with the Bureau of Indian Affairs to accumulate and earn interest until said minor has reached legal age; and,

WHEREAS, Resolution No. 19-145 previously authorized the distribution of a \$400.00 per capita distribution during the month of August, 2019; and

WHEREAS, the Tribal Council desires to move said distribution from August 7, 2019 to July 31, 2019; and now, therefore,

BE IT RESOLVED, by the Tribal Council of the Confederated Salish and Kootenai Tribes that the Northwest Regional Director is requested to authorize the \$400.00 per capita distribution to be made during the month of July 2019; and

BE IT FURTHER RESOLVED, that the Director of Financial Management is directed and authorized to request sufficient tribal monies on deposit in the United States Treasury to be advanced to local status to effect said distribution; and

BE IT FURTHER RESOLVED, that the Superintendent, Flathead Agency, and the Director of Financial Management are authorized to apply these funds to judgments held by Tribal Court, to assignments through Tribal Credit, and voluntary child support and to those accounts under the control of the Superintendent; and

BE IT FURTHER RESOLVED, that the July 31, 2019 per capita distribution will be made to those members enrolled in the Tribes as of July 18, 2019 at 5:30 p.m., and

BE IT FINALLY RESOLVED that the deadline for claims to be withheld from individuals' July 31, 2019 per capita for judgments, assignments and IIM holds through the Superintendent and Director of Financial Management shall be no later than July 11, 2019 at 5:30 p.m.

RESOLUTION SUPPORTING SUBMITTAL OF THE FY 2020 APPLICATION FOR THE FOOD DISRIBUTION PROGRAM ON INDIAN RESERVATIONS (COMMODITY) PROGRAM

BE IT RESOULVED BY THE TRIBAL COUNCIL OF THE CONFEDERATED SALISH AND KOOTENAI TRIBES THAT:

WHEREAS, the Confederated Salish and Kootenai Tribes have prepared a budget request for funds to continue to operate the Tribes Commodity Program and,

WHEREAS, the Tribal Council has created the Department of Human Resources Development (DHRD) to ensure that families receive the support necessary to achieve self sufficiency including nutritional supports and the Commodity Program provides such supports, and

WHEREAS, the Department of Human Resources Development is the lead agency for continued operation of the Commodity Program and respectfully requests that the State of Montana, DPHHS, FDPIR, provide funds for continued operation of the program, as requested.

NOW THEREFORE BE IT RESOLVED THAT, The Tribal Council Chairman and his designated representative are authorized to negotiate and execute the grant and or contact documents and any amendments thereto, Patricia Courchane and Natalie Kenmille, Department of HRD, requested to submit the new three year plan for the Public Law 477 program and the plans for the programs that are part of 477. Every three years, DHRD must submit plans for the 477 program which includes the programs that are part of the

477 program. This includes TANF, Childcare, Office of Community Services Block Grant (OCS), WIOA, BIA training and NEW.

WHEREAS, the Confederated Salish and Kootenai Tribes have had an approved Tribal Family Assistance Plan (TFAP) since January 1999 to provide TANF benefits to eligible participants and an approved Public Law 102-477 plan which integrates the TANF program into a comprehensive employment and training plan for integrated services to low income people who are working towards self-sufficiency, and

WHEREAS, the Confederated Salish and Kootenai Tribes receive Child Care Development Funds (CCDF) to administer child care benefits to eligible participants and is integrated into the approved Public Law 102-477 Plan, and

WHEREAS, the Confederated Salish and Kootenai Tribes receives Workforce Investment Opportunity Act (WIOA) Adult – DOL funds to administer work activities and work support benefits, and is integrated into the approved Public Law 102-477 Plan, and

WHEREAS, the Confederated Salish and Kootenai Tribes receives Supplemental Youth Services Allocation DOL funding to administer work activities and work placement funds, and is integrated into the approved Public Law 102-477 Plan, and

WHEREAS, the Confederated Salish and Kootenai Tribes received BIA Job Placement and Training Funds to administer work activities and work placement funds, and is integrated into the approved Public Law 102-477 Plan, and

WHEREAS, the Confederated Salish and Kootenai Tribes receives Native Employment Work Program Department of Health and Human Services funds and is integrated into the approved Public Law 102-477 Plan, and

WHEREAS, the Confederated Salish and Kootenai Tribes receives General Assistance/cash assistance funds thru the BIA to administer services to single adults, and is integrated into the approved Public Law 102-477 Plan, and
