RESOLUTION OF THE GOVERNING BODY OF THE CONFEDERATED SALISH AND KOOTENAI

TRIBES OF THE FLATHEAD NATION

RESOLUTION APPROVING SMALL BUSINESS GRANT AWARDS AS ALLOCATED BYTHE C.A.R.E.S. (CORONA VIRUS AID, RELIEF AND ECONOMIC SECURITY) ACT TO PROVIDE RELIEF OF COVID 19 IMPACTS ON TRIBAL MEMBER OWNED BUSINESSES

BE IT RESOLVED BY THE TRIBAL COUNCIL OF THE CONFEDERATED SALISH AND KOOTENAI TRIBES THAT:

WHEREAS, the Tribal Council of the Confederated Salish and Kootenai Tribes is the duly recognized governing body of the Flathead Reservation; and WHEREAS, the Confederated Salish and Kootenai Tribes are committed to the sound planning and management of Flathead Reservation resources; and WHEREAS, the Confederated Salish and Kootenai Tribes have directed the Office of Economic Development to fill the important need of diversification of revenues and protection of resources as the Tribes strive for self-sufficiency and planned economic development opportunities; and WHEREAS, the Confederated Salish and Kootenai Tribes recognize the devastating economic impact of the persistent COVID-19 pandemic on Tribal member-owned businesses and agricultural producers operating on the Flathead Reservation; and WHEREAS, the Tribal Council has designated Coronavirus Relief Funds to support Tribal member small businesses in the recovery, stabilization, and adaptation of operations as part of the Tribes' Economic Recovery and Revitalization initiative; and WHEREAS, the Economic Development Office and the Salish and Kootenai Business Services have processed electronic applications through extensive reviews and present a list of Tribal member businesses for approval of grant awards; NOW, THEREFORE, BE IT RESOLVED, that CSKT Small Business Relief Grants are awarded to the successful qualified Tribal businesses as listed to stabilize and adapt operations as they continue to navigate the challenges of the global health pandemic on the Flathead Reservation. BE IT FURTHER RESOLVED, that all awardees will enter into a Memorandum of Agreement and Subaward Recipient Agreement in compliance with CSKT Contracts and Grants procedure for award disbursement. BE IT FINALLY RESOLVED, that the Confederated Salish and Kootenai Tribes authorize Business Relief Grant awards as allocated by the U.S. Department of Treasury's CARES ACT to the attached list of Tribal member small businesses and agricultural producers in the amounts specified to stabilize operations and adapt to Covid 19 pandemic challenges.
